The final Stage Screening of the candidates who have been declared successful in First Stage Screening held from 15.02.2017 to 21.02.2017 (result displayed on Lok Sabha Webiste: http://www.loksabha.nic.in under the heading Recruitment) for short term need based engagement of Casual Labour in Lok Sabha Secretariat, will be held on 15th and 16th April, 2017 in Parliament House Annexe Building (near PTI Building), New Delhi-110001.

2. Call Letters to the candidates are being issued by **Speed Post.**

- 3. The Final Stage Screening will be of 25 Marks. The minimum cut off percentage of marks is 50%, 45% and 40% for vacancies in UR, OBC and SC/ST categories, respectively. From amongst the candidates who secure the minimum qualifying marks in the Final Stage Screening, the selection will be made on the basis of the performance of the candidates in the Final Stage Screening, subject to availability of vacancies. The marks secured by the candidates in the 1st stage of Screening will not be counted while preparing the final selection list.
- 4. The candidates should bring all the relevant original certificates along with photocopies of the following certificates **duly attested by a First Class Magistrate or Gazetted Officer** at the time of Final Stage Screening:
 - (i) Matriculation or equivalent examination certificate as proof of date of birth
 - (ii) Educational Qualifications (both Certificates/Degrees and Marks Sheets)
 - (iii) Category/Caste Certificate (PH, SC, ST and OBC certificates, wherever applicable, in the prescribed format)

[Other Backward Class (OBC) means those communities as included and specified in the Central Government list of the backward classes. OBC certificate of a candidate must show that the caste the candidate belongs to is recognized as OBC under various Resolutions of the Ministry of Welfare, Government of India, and that the person does not belong to creamy layer section.

A candidate claiming to be belonging to OBC but not submitting OBC certificate which satisfy these two conditions will be treated as General Category candidate and will not be provided any benefit available to OBC candidates.]

- 5. It may please be noted that <u>NO</u> TA shall be reimbursed for appearing in the aforesaid Screening. Further, the candidature of the candidates appearing in the Final Stage Screening is provisional and it can be cancelled at any time in case any declaration in application does not match with the requirements advertised for the post. The candidates are, therefore, required to satisfy themselves that they fulfil the eligibility conditions for the post as advertised, before attending the Final Stage Screening.
- 6. At the time of Final Stage Screening, the candidates(s) must carry a valid photo ID proof such as PAN Card/Passport/Voter ID/Driving Licence/Aadhaar Card/Permanent Identity Card issued by a University/College or any other valid proof of identification having their latest photograph alongwith this Call Letter. Otherwise they will not be allowed to appear in the Final Stage Screening.
- 7. Attempts to influence or pressurise the Selection Process including canvassing in any manner would lead to summary rejection of the candidature.
- 8. Please note that mobile phone etc. and other similar electronic gadgets will not be allowed inside the venue of the Screening Test. It is, therefore, advised **NOT** to bring these items to the venue of the Screening Test as no arrangements for safekeeping of these items have been made.
