## TERMS AND CONDITIONS OF THE TENDER

### DISPOSAL OF OLD/UNSERVICABLE (CONDEMNED) MACHINES/EQUIPMENTS AND CONSUMABLES ITEMS

#### 1. Earnest Money Deposit

- (i) The Earnest Money Deposit (EMD) Rs.25,000/- (Rupees Twenty Five Thousand only) should be accompanied with the bid(Financial/Price Bid- Annexure-II) in the form of Demand Draft/Banker Cheque drawn in favour of '**Drawing and Disbursing Officer, Lok Sabha**. Bid received without EMD or EMD for fewer amounts will be summarily rejected. The submission of EMD is compulsory for all the bidders and no exemption will be granted for submission of EMD in any case.
- (ii) EMD will be forfeited if the bidders withdraw after submission of the bids or opening of the tenders.
- (iii) EMD will be returned to the unsuccessful bidders three days after bid opening.
- (iv) EMD will be adjusted for the purpose of final payment by the successful bidder.

#### 2. Payment of entire bid amount

The successful bidder will have to pay the entire bid amount in the form of demand draft drawn in favour of '**Drawing and Disbursing Officer, Lok Sabha** before taking away the items which should be not less than 3 days of the bidding.

#### 3. Mode of Submission of bid and last date for submission

**Financial/Price Bid** as per prescribed format(Annexure-II) along with **Demand Draft of EMD** in a sealed envelope should be addressed to the **Director(GPS&SCTC), General Procurement Branch, Lok Sabha Secretariat, Room No.408, Parliament House Annexe, New Delhi**, and must reach on or before **04.09.2015 by 1500 hrs.** Tenders may be hand delivered at the afore mentioned address. Bids received after the closing date and time prescribed shall **NOT** be accepted under any circumstances.

#### 4. Rejection of incomplete and conditional tenders

The incomplete and conditional tenders will be rejected.

#### 5. No withdrawal after submission of bids

No bidders will be allowed to withdraw after submission of bids/opening of the tender; otherwise the EMD submitted by the firm would be forfeited.

#### 6. Non transferability

This tender is non transferable.

#### 7. Bidding for the entire range of items meant for disposal.

The bidders have to bid for entire lot. Bidding for select items will not be entertained.

## 8. Removal of the goods at the bidders cost.

The successful bidder has to take away the items at their own cost within 3 days after making complete payment of the items. Prescribed security procedure has to be followed for taking away the items from the Lok Sabha Secretariat premises. In case, the successful bidder deposits the full amount within 3(three) days but fails to lift the articles, the department shall not take responsibility for safe custody of the articles. On the other hand ground rent@1% of the total amount of the bid value shall be charged for each day of default upto maximum 10 days. In case, the successful bidder is unable to take delivery of the items even after penalty of 10 days, EMD submitted by them will be forfeited and the bidder will be **blacklisted**.

Items will be disposed of on “**As is where is basis**”.
